Methodology

Geography: Georgia (Abkhazia and South Ossetia excluded), Moldova (Transnistria excluded) and Ukraine (temporarily occupied territories of Donetsk, Luhansk, Kherson, Kharkiv, Mykolaiv and Zaporizhzhia regions as well as Crimea excluded).

Method: Computer Assisted Telephone Interview (CATI).

Time period: Georgia – Jun 27-Jul 8, Moldova – Jun 21-Jul 14, Ukraine – Jun 6-15

Methodology


Sample size: Georgia – 1228, Moldova – 600, Ukraine – 997.

A random sample of all possible mobile phone numbers in each country.

The results are weighted according to the latest available official data on the distribution of the population by sex, age, region and type of settlement. In Georgia, the sample was also refined by education level and ethnicity according to the 2014 census.




Sample Demographic Structure - SEX






Sample Demographic Structure - AGE



Sample Demographic Structure – SETTLEMENT TYPE


















5. Democracy is compatible with authoritarian leadership






6. Ordinary citizens can influence decisionmaking in my country






7. Political institutions should be accountable to citizens






8. Political institutions should set rules rather than control citizens






9. Democratic values are less important than security for my country






10. I share European values of human dignity, freedom, democracy, equality, rule of law, and human rights






11. Traditional values of my country are threatened by European values






12. Men and women should enjoy equal rights in my country






13. Individual freedoms are important for achieving a 'good life' in my country






14. It is the people and not the government who should define the meaning of the 'good life' in democracy






15. If the country is doing well economically, I don't care who is in power






16. Empowering local governments improves democracy in our country






17. Civic engagement on the local level contributes to democracy in my country






18. Participation in local governments improves democracy in my country






19. Volunteering is a way of contributing to the life of my community






20. Grassroots traditions are important for a democracy






21. European Union has no influence on promotion of reforms in my country






22. The EU demands our government to be more democratic






23. The Parliament of my country represents interests of its citizens






24. The government of my country represents interests of its citizens






25. I trust most people in my country






26. One should never trust politicians






27. One cannot trust political institutions in our country
