
REINTEGRATION OF LIBERATED COMMUNITIES AND SOCIAL COHESION: THIRD WAVE

METHODOLOGY

- Audience: population of Ukraine aged 18 and older in all oblasts, except for the temporarily occupied territories of Crimea and Donbas, as well as territories where there was no Ukrainian mobile connection at the time of the survey. The results are weighted using up-to-date data from the State Statistics Service
- The sample is representative by age, gender, and type of settlement
- Sample population: 2010 respondents
- Survey method: CATI Computer Assisted Telephone Interviewing based on a random sample of mobile phone numbers
- Error of representativeness of the study with a confidence level of 0.95: not more than 2.2%
- Dates of the survey: 21.09.2024 10.10.2024



WAS YOUR HOME DESTROYED DURING HOSTILITIES AFTER FEBRUARY 24, 2022?


















PERCEPTIONS OF LIFE IN THE TEMPORARY OCCUPIED TERRITORIES AND SOURCES OF INFORMATION



WHAT TO DO WITH POLICE OFFICERS AND LIFEGUARDS WHO WORKED IN THE OCCUPIED TERRITORIES?








